#### COLORADO ANTELOPE REFUGE

(S. B. No. 446, by Senators Wilson and Warren)

## AN ACT

TO CREATE AND ESTABLISH THE COLORADO ANTE-LOPE REFUGE, AND TO REGULATE AND PROHIBIT THE HUNTING OR KILLING OF GAME THEREIN, AND TO PROVIDE CERTAIN PENALTIES.

Be It Enacted by the General Assembly of the State of Colorado:

Colorado Antelope Refuge

Boundaries

Section 1. For the better protection of the (Antelocarpa americana) and other animals and birds and the establishment of breeding places therefor, the following area within the State of Colorado is hereby set aside, designated, and established as a State Game Refuge: All that portion of the State of Colorado embraced in Townships Ten (10), Eleven (11), and Twelve (12) North, Range Sixty-eight (68) West, 6th Principal Meridian, and the West Half of Township Ten (10) North, Range Sixty-seven (67) West, and the West Half of Township Eleven (11) North, Range Sixty-seven (67) West, 6th Principal Meridian, which area shall constitute and be known as THE COLORADO ANTELOPE REFUGE.

Hunting, etc., unlawful

Section 2. It shall be unlawful for any person or persons, at any time, to hunt, trap, kill, capture or

chase any birds or animals of any kind or description whatever except as herein provided within the limits of the Colorado Antelope Refuge: PROVIDED, Exceptions That the provisions of this act shall not apply to the killing, capture or destruction of any mountain lion, wolf, fox, coyote, lynx, wildcat, mink, marten, or wolverine, or any bird or animal not protected by the laws of the State of Colorado: and PRO-VIDED, It shall be unlawful for any person to hunt, trap, kill, capture or chase any of the above excepted animals or birds within said refuge without a permit from the State Game and Fish Commissioner.

Section 3. Upon application by any person, the Permit to hunt excepted State Game and Fish Commissioner may, in his discretion, grant a permit to such person to hunt, kill, trap, capture, or chase any of the animals or birds excepted by the provisions of Section two hereof.

Section 4. Any person violating the provisions Misdemeanor of this Act shall be deemed guilty of a misdemeanor and shall, upon conviction, be fined the sum of not less than twenty-five dollars nor more than five hundred dollars, or shall be imprisoned in the county jail for a period of not less than three months, nor more than one year; or both such fine and imprisonment in the discretion of the court.

Section 5. The General Assembly hereby de- Safety clause clares that this Act is necessary for the immediate preservation of the public peace, health and safety.

Section 6. In the opinion of the General As- Emergency sembly an emergency exists; therefore, this Act shall take effect and be in force from and after its passage.

#### DENVER MOUNTAIN PARKS STATE GAME REFUGE

(S. B. No. 438, by Senator Dodge)

## AN ACT

TO CREATE AND ESTABLISH THE CITY OF DENVER STATE GAME REFUGE, AND TO REGULATE AND PROHIBIT THE HUNTING OR KILLING OF GAME THEREIN, AND TO PROVIDE CERTAIN PENALTIES.

Be It Enacted by the General Assembly of the State of Colorado:

Denver Mountain Parks State Game Refuge

Section 1. For the better protection of birds and animals and the establishment of breeding places therefor, the following area within the State of Colorado is hereby set aside, designated, and established as a State Game Refuge: All that portion of the State of Colorado embraced within the following described boundary, which area shall constitute and be known as the Denver Mountain Parks State Game Refuge:

Boundaries

Beginning at a point on the north bank of Clear Creek, at the western limits of the town of Golden; thence following westerly along said north bank of Clear Creek to Georgetown; thence westerly and southerly along the north and left bank of Middle Clear Creek to its source just under Loveland Pass on the Continental Divide; thence along the highway to the summit of the Divide at Loveland Pass; thence following in a general southerly direction

along the crest of the Divide, which coincides with the east boundary of Summit County, to Webster Pass; thence in a general southerly and southeasterly direction down Handcart Gulch and Hall Gulch, following the left bank to its confluence with the North Fork of the South Platte River; thence following along the left bank of the said North Fork of the South Platte River to its confluence with the South Fork of the South Platte River; thence in a general northeasterly direction along the left bank of the South Platte River to Waterton; thence in a northerly and westerly direction, following the road which leads to Morrison through approximately Sections 34, 27, 28, 21, 20, 17, 7, 8, 5 and 6, Township Six (6) South, Range Sixty-nine (69) West, Sixth (6th) Principal Meridian; Sections 31 and 30, Township Five (5) South, Range Sixty-nine (69) West, Sixth (6th) Principal Meridian; Sections 25, 24, 13, 14, 11, and 2, Township Five (5) South, Range Seventy (70) West, Sixth (6th) Principal Meridian; through the town of Morrison and along road leading to Golden, crossing approximately Sections 35, 26, 23, 22, 15, 10 and 3, Township Four (4) South, Range Seventy (70) West, Sixth (6th) Principal Meridian; and Sections 34 and 33, Township Three (3) South, Range Seventy (70) West, Sixth (6th) Principal Meridian, to the west boundary of the town of Golden; thence following the exterior boundary of the town of Golden in a northerly direction to the point of beginning.

Section 2. It shall be unlawful for any person or persons, at any time, to hunt, kill, trap, capture or chase any bird or animal of any kind or description whatever except as herein provided within the limits of the Denver Mountain Parks State Game Ref-

uge; Provided, That the provisions of this Act shall not apply to the killing, capture or destruction of any mountain lion, wolf, fox, coyote, lynx, wildcat, mink, marten, or wolverine, or any bird or animal not protected by the laws of the State of Colorado; and, Provided, It shall be unlawful for any person to hunt, kill, trap, capture or chase any of the above excepted animals or birds within said refuge without a permit from the State Game and Fish Commissioner.

Permit to hunt excepted animals

Section 3. Upon application by any person, the State Game and Fish Commissioner may, in his discretion, grant a permit to such person to hunt, kill, trap, capture or chase any of the animals or birds excepted by the provisions of Section 2 hereof.

Misdemeanor

Section 4. Any person violating the provisions of this Act shall be deemed guilty of a misdemeanor and shall, upon conviction, be fined the sum of not less than twenty-five dollars nor more than five hundred dollars, or shall be imprisoned in the county jail for a period of not less than three months, nor more than one year; or both such fine and imprisonment in the discretion of the court.

# GAME REFUGE PIKE'S PEAK STATE GAME PRESERVE

(S. B. No. 447, by Senator King)

# AN ACT

TO CREATE AND ESTABLISH THE PIKE'S PEAK STATE GAME REFUGE, AND TO REGULATE AND PRO-HIBIT THE HUNTING OR KILLING OF GAME THERE-IN, AND TO PROVIDE CERTAIN PENALTIES.

Be It Enacted by the General Assembly of the State of Colorado:

Section 1. For the better protection of birds Pike's Peak State Game and animals and the establishment of breeding Preserve places therefor, the following area within the State of Colorado is hereby set aside, designated and established as a State Game Refuge: All that portion of the State of Colorado, embraced within the following described boundary, which area shall constitute and be known as the PIKE'S PEAK STATE GAME PRESERVE:

Beginning at a point on the east boundary of the Boundaries Pike National Forest, which is the northeast corner of Section Four (4), Township Thirteen (13) South, Range Sixty-seven (67) West, Sixth (6th) Principal Meridian: thence due west to the intersection of the western boundary of said Pike National Forest at a point which is the northwest corner of Township Thirteen (13) South, Range Sixty-eight (68) West;

thence due south along the said boundary to a point. which is southwest corner of Section Eighteen (18) of Township Thirteen (13) South, Range Sixty-eight (68) West: thence due west along said boundary to a point which is the northwest corner of Section Nineteen (19), Township Thirteen (13) Range Sixty-nine (69) West; thence in a general southerly and easterly direction along said boundary to a point which is the southwest corner of Township Fifteen (15) South, Range Sixty-eight (68) West: thence due east along the southern boundary of the Pike National Forest to a point which is southwest corner of Section Thirty-four (34), Township Fifteen (15) South, Range Sixty-seven (67) West: thence along the eastern boundary of the Pike National Forest in a general northerly direction to the . point of beginning.

Hunting, etc.,

Section 2. It shall be unlawful for any person or persons, at any time, to hunt, trap, kill, capture or chase any birds or animals of any kind or description whatever except as herein provided within the limits of the Pike's Peak State Game Preserve; PRO-VIDED, that the provisions of this act shall not apply to the killing, capture or destruction of any mountain lion, wolf, fox, coyote, lynx, wildcat, mink, marten or wolverine, or any bird or animal not protected by the laws of the State of Colorado; and, PRO-VIDED, it shall be unlawful for any person to hunt, trap, kill, capture or chase any of the above excepted animals or birds within said refuge without a permit from the State Game and Fish Commissioner.

Exceptions

Section 3. Upon application by any person, the State Game and Fish Commissioner may, in his discretion, grant a permit to such person to hunt, kill,

#### SPANISH PEAKS STATE GAME PRESERVE

(S. B. No. 455, by Senators Stephens and East)

## AN ACT

TO CREATE AND ESTABLISH THE SPANISH PEAKS STATE GAME REFUGE, AND TO REGULATE AND PROHIBIT THE HUNTING OR KILLING OF GAME THEREIN, AND TO PROVIDE CERTAIN PENALTIES.

Be It Enacted by the General Assembly of the State of Colorado:

Spanish Peaks State Game Refuge Section 1. For the better protection of birds and animals and the establishment of breeding places therefor, the following area within the State of Colorado is hereby set aside, designated, and established as a State Game Preserve: All that portion of the State of Colorado embraced within the following described boundary, which area shall constitute and be known as the SPANISH PEAKS STATE GAME PRESERVE:

Boundaries

Beginning at a point on the boundary of the San Isabel National Forest, which point is the northeast corner of Section Twenty-one (21), Township Thirty (30) South, Range Sixty-seven (67) West, Sixth (6th) Principal Meridian; thence following in a counter clockwise direction the boundary of the Spanish Peaks Division of the San Isabel National Forest to the point of beginning.

Unlawful to hunt, trap, etc. Section 2. It shall be unlawful for any person or persons, at any time, to hunt, trap, kill, capture or

chase any birds or animals of any kind or description whatever except as herein provided within the limits of the Spanish Peaks State Game Preserve; PROVIDED. That the provisions of this act shall not apply to the killing, capture or destruction of any Exceptions mountain lion, wolf, fox, coyote, lynx, wildcat, mink, marten, or wolverine, or any bird or animal not protected by the laws of the State of Colorado; and, PROVIDED, it shall be unlawful for any person to hunt, trap, kill, capture or chase any of the above excepted animals or birds within said refuge without a permit from the State Game and Fish Commissioner.

Section 3. Upon application by any person, the State Game and Fish Commissioner may, in his discretion, grant a permit to such person to hunt, kill, trap, capture, or chase any of the animals or birds excepted by the provisions of Section two hereof.

Permit to hunt

Section 4. Any person violating the provisions of this act shall be deemed guilty of a misdemeanor Misdemeand and shall, upon conviction, be fined the sum of not less than twenty-five dollars nor more than five hundred dollars, or shall be imprisoned in the county Penalty jail for a period of not less than three months, nor more than one year; or both such fine and imprisonment in the discretion of the court.

Section 5. The General Assembly hereby declares that this Act is necessary for the immediate preservation of the public peace, health and safety.

Section 6. In the opinion of the General Assembly an emergency exists; therefore, this Act shall take effect and be in force from and after its passage.
