

## SENATE JOINT RESOLUTION NO. 16

(By Senator Twining)

WHEREAS, There can no longer be reasonable doubt that the present occupant of the White House will find his place in the galaxy of American immortals and will, as the years roll on, loom ever larger and larger, an illustrious figure in the panorama of American history and,

WHEREAS, For more than four years, his commanding spirit and beneficent works have dominated every aspect of American life, leading our Nation out of the depths of a major economic catastrophe and into an era of good feeling, characterized by a sense of economic security for millions, and

WHEREAS, Words will always be weak and ineffective instruments to properly portray the lofty character and dynamic spirit of our beloved President, we urge that Colorado dedicate in his honor a worthy and perpetual monument.

BE IT THEREFORE RESOLVED by the Senate with the House concurring that Colorado be the first to honor him by naming one its noblest mountain peaks, Mt. Franklin Roosevelt, as an eternal monument to our most eminent citizen, its grandeur in keeping with his greatness.

BE IT FURTHER RESOLVED that this mountain be one of Presidential grandeur, an imposing peak which will not be exceeded in height or impressiveness by any adjacent peak nor shall this Mt. Roosevelt be less than 14,000 feet in elevation.

BE IT FURTHER RESOLVED that a committee composed of three members of the Senate, appointed by the President of the Senate, and four members of the House of Representatives, be designated to select the mountain which is to be named Mt. Franklin Roosevelt, the said committee to be charged with the duty of weighing all facts submitted to it bearing on the selection of a Mt. Roosevelt, in Colorado and the choice of the committee to be considered the choice of the people of the State of Colorado.

BE IT FURTHER RESOLVED, that Colorado's Representative in the National Congress at Washington, D. C., be notified of the selection of a Mt. Franklin Roosevelt in Colorado and be requested to place it in proper form before the National Congress for its adoption by that body.

BE IT FURTHER RESOLVED, that the selection by the committee shall be made on or before May 15, 1937, or before the present session of the Thirty-first General Assembly adjourns sine die.

Your committee appointed under the provisions of Senate Joint Resolution No. 16 for the purpose of selecting a mountain peak to be designated "Mount Franklin Roosevelt" begs to report as follows:

After careful and prolonged consideration your committee has selected a mountain peak of outstanding

beauty and grandeur formerly known as Mount Wilson, located twelve miles south of Telluride, Colorado in Dolores County, adjacent to the main highway between Telluride and Dolores, Colorado, to be designated as "Mount Franklin Roosevelt". This peak is located in one of the most mountainous and beautiful sections of the State of Colorado and your committee feels that the designation of said peak as "Mount Franklin Roosevelt" expresses faithfully the desire of the General Assembly to perpetuate and honor the name of Franklin D. Roosevelt.

Your committee requests that the Senators and Representatives of the State of Colorado and the proper officials of the United States government be notified that said peak has been properly designated as provided by said resolution.
